- 2) The parent has received a written acknowledgment from one Nevada district that the child is being homeschooled, and the child has moved to another district. The initial filing must be submitted in the new district at the beginning of the next school year; **or**
- 3) The child has moved from out of state into a Nevada school district. The initial filing must be submitted within thirty days of establishing residency; **or**
- 4) The parent begins homeschooling the child after discontinuing another educational method, as defined by NRS 385.007.

- A. **The proposed educational goals** (NAC392.011, #3) which is a description of the anticipated kind of instruction, by subject, for one school year; **or**
